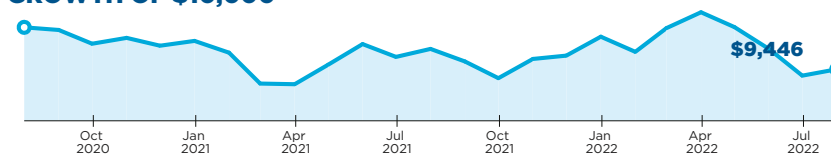

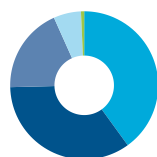

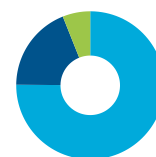
- Ability to tactically shift allocation between physical bullion and gold equities depending on market conditions.
