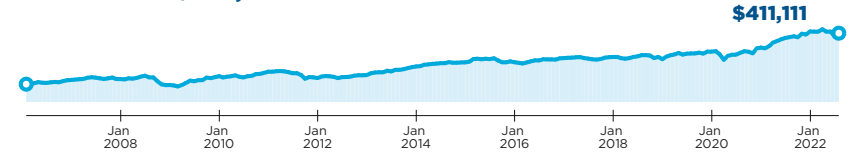

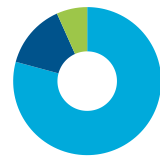

### GROWTH OF \$100,000



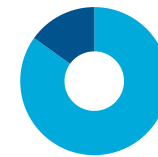

### ASSET ALLOCATION



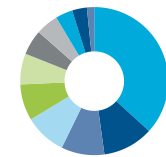
