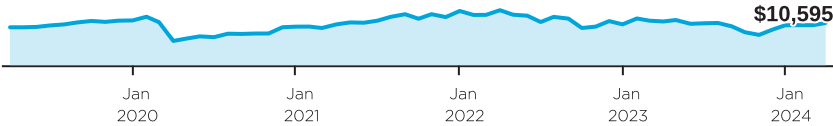

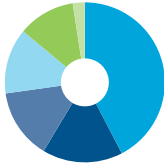
WHY INVEST IN DYNAMIC REAL ESTATE & INFRASTRUCTURE INCOME II FUND ?

GROWTH OF \$10,000

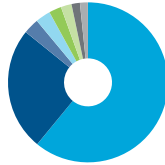


ASSET ALLOCATION



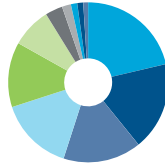
